December 13, 2022	FHFA sends “Notice of Relevant Dates for the 2023 Community Support Program (CSP) Biennial Review” to FHLBanks	The Notice of Relevant Dates for the 2023 CSP Biennial Review provides the applicable dates for the 2023 CSP Review. FHLBank members subject to the 2023 CSP review are required to submit their Community Support Statements (CSSs) to FHFA from April 3, 2023 to October 31, 2023.
January 9, 2023	FHFA posts Important Key Dates of the 2023 CSP Biennial Review	The document provides the “Important Key Dates of the 2023 CSP Biennial Review.”
January 20, 2023	FHFA posts on CSP website the “Instructions for the 2023 CSP Biennial Review”	The “Instructions for the 2023 CSP Biennial Review” document provides CSP and CSS information and instructions.
January 20, 2023	FHLBanks send CSP Website Address Link to FHFA	Each FHLBank is required to send its CSP website address link to FHFA at @HMGCommunitySupportProgram@fhfa.gov . Each FHLBank’s link will be included in the forthcoming Federal Register’s “FHFA Notice of Opportunity to Comment on FHLBank Members Community Support Performance.”
February 2, 2023	Part I: Training for FHLBanks (Part I)	FHFA host training for the FHLBanks on administering the CSP.
By February 22, 2023	FHLBanks send “Notice of Opportunity to Comment on FHLBank Members Community Support Performance”	By February 22, 2023, each FHLBank must provide notice of the opportunity to comment on each members’ community support performance. This requirement includes posting a notice on the FHLBank’s public website and sending notices to its Advisory Council, nonprofit housing developers, community groups, and other interested parties in its district. The notices must list the name and address of each member subject to community support review. The 30-day comment period will begin February 23, 2023 and end March 24, 2023. Comments must be submitted to FHFA at @HMGcommunitysupportprogram@fhfa.gov .
February 23, 2023	FHFA publishes Federal Register Notice – “FHFA’s Notice of Opportunity to Comment on FHLBank Members Community Support Performance”	FHFA will publish the “Notice of Opportunity to Comment on FHLBank Members Community Support Performance” in the Federal Register on February 23, 2023, with a 30-day comment period. The Notice provides the public an opportunity to comment on members’ community support performance. The deadline for commenting will be March 24, 2023. Public comments can be emailed to FHFA at @HMGcommunitysupportprogram@fhfa.gov . FHFA will consider any public comments it has received concerning a FHLBank member when reviewing the FHLBank member for community support compliance. FHFA provides each FHLBank community support representative a copy of the Federal Register Notice. The Notice will provide instructions and deadline for submission of public comments. It will also direct the public to the individual FHLBank’s public website for additional information on members subject to the review.
March 3, 2023	FHLBank CSP Representatives provide FHFA CSP Contact Information	If applicable, each FHLBank must provide at least two FHLBank user contact names to FHFA. One FHLBank user must be the FHLBank CSP administrator or primary contact. Along with the names, please provide the following information: contact’s title, telephone number and email address. March 10, 2023	FHLBanks submit updated CSP Access Request Forms(s), if necessary	The FHLBanks must review their current CSP Access Request Forms for accuracy. Please submit a new CSP Access Request Form if necessary to add or delete a staff employee's access to the CSP system.
March 24, 2023	Federal Register Notice Comment Period Ends	Federal Register Notice comment period ends.
To Be Determined	Part II: Training for FHLBanks	The training will cover how FHFA will administer the CSP, the functionality of the CSS Portal, and answer questions from the FHLBanks.
March 31, 2023	FHLBanks provide notice to FHLBank Members to submit Community Support Statements	By March 31, 2023, each FHLBank must notify each FHLBank member subject to the community support review to submit its completed Community Support Statement to FHFA during a submission period beginning April 3, 2023 and ending October 31, 2023.
April 3, 2023	FHLBanks provide their CSP Policies and Procedures to FHFA	By April 3, 2023, each FHLBank provides its 2023 CSP Biennial Review Policies and Procedures to FHFA at @HMGCommunitySupportProgram@fhfa.gov .
Beginning April 3, 2023	FHFA Begins Accepting CSSs for the 2023 Biennial Review	FHLBank members subject to the 2023 CSP Biennial Review are required to start submitting their CSSs.
Beginning April 3, 2023	FHFA Reviews CSSs and Sends Results to FHLBanks	FHFA begins reviewing members' CSSs and provides review results to FHLBanks' community support representatives.
October 31, 2023	CSSs Submission Deadline	FHLBank Members complete their submission of CSSs.
