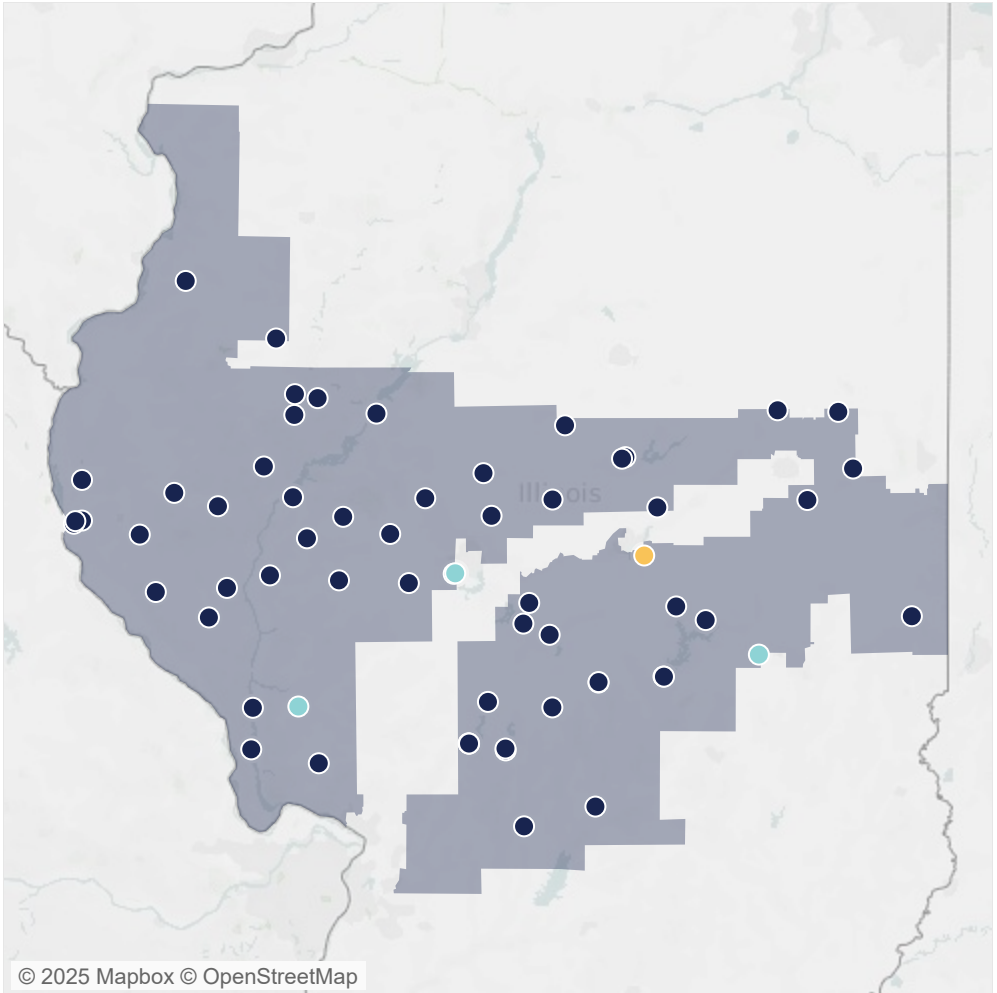

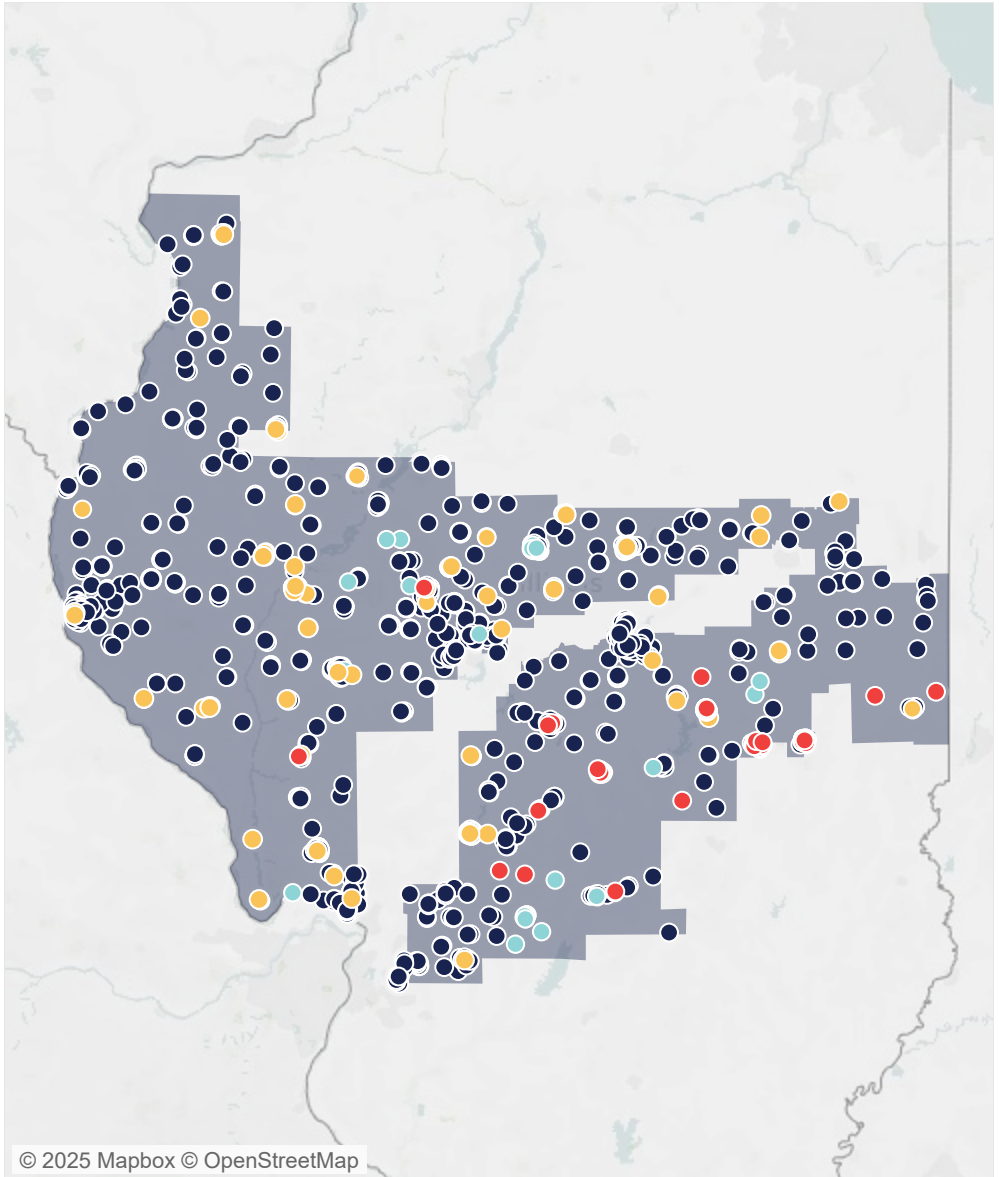

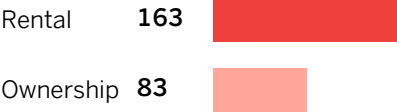
Affordable Housing Program (AHP)

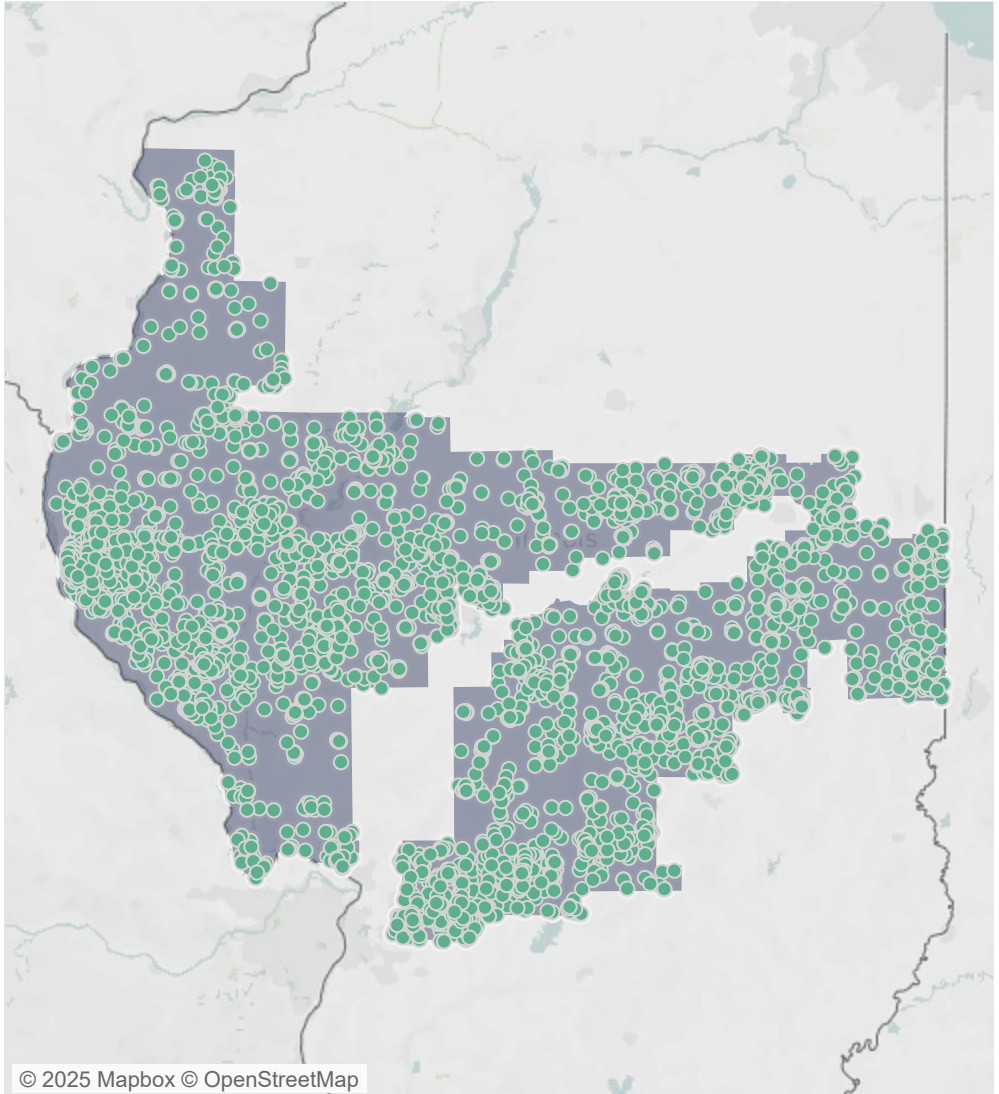
